- **OROFACIAL PAIN... 5 Cases you didn't think of!**

A thoughtful approach to deconstructing a patient's presentation with orofacial pain. What to ask (everything), how to ask it, and why you're asking it. In this lecture, you will be introduced to various orofacial pain conditions in a case-based format. Participants will be exposed to various orofacial pain conditions that may show up in their dental office ranging from non-odontogenic toothaches to temporomandibular joint disorders to systemic conditions that may affect the head and neck. At the end of the lecture, participants will become familiar with how to spot and diagnose orofacial pain conditions and gain a better understanding of treatment modalities.

- **THE USE & ABUSE OF ANTIBIOTICS IN ENDODONTIC INFECTIONS**

It is estimated that 30% of the world's population suffers from untreated pulpal infections. These infections cause reduced quality of life from pain, swelling, and limit one's ability to eat, drink and speak. Scientific literature consistently highlights the tremendous benefits of the use of antibiotics to help control these infections. However, the value of these drugs in preventing serious health complications can be undermined by the misuse of antibiotic prescriptions and lead to adverse consequences.
